

# ARGENTARIO DANCE FESTIVAL 2014

## REGULATIONS FOR THE ARGENTARIO DANCE FESTIVAL 2014

**Clause 1:** All participants, soloist or groups must pay individually 10,00€ each for insurance.

**Clause 2:** With this competition the A.S.D: Ballet Center Academy intends to promote and sustain the development of the art of dance such as Ballet, Repertory, Contemporary, Modern-Jazz, Dance Show, Hip-Hop.

**Clause 3:** The competition is divided into categories Under and Over. For the category UNDER (from 5 to 14 years) for Category OVER (from 15 years old) are provided for the following sections: Soloist: Classic - Repertoire - Contemporary - Modern Jazz Group: Modern - Contemporary - Dance Show - Hip Hop in all its styles.  
If the number is not reached, there will be a single category.

**Clause 4:** Documents necessary for registration:

- A signed copy of regulations
- Registration form signed and completed
- Birth certificate or self certification of participants (signed by parents or tutor)
- Medical certificate stating the valid date of the event
- A signed authorization from a parent or tutor of minors taking part in the competition.
- A complete list of all participants.

**Clause 5:** Each school registered, solo or group, can participate with only one choreography for each category.

**Clause 6:** The definition of the category "group" is the minimum of 3 participants.

**Clause 7:** The registration together with the before mentioned documentation must be

received by 3th July 2014 at the latest.  
No enrolment fees are required for foreign participants. € 10,00 are required for each student dancer to cover personal insurance for the whole period. Ask us for Iban number and send a copy of the bank receipt by e-mail.

**Clause 8:** The maximum time for each choreography is:  
Soloists 3 minutes  
Passi a due 3 minutes  
Groups 4 minutes  
The participants must present themselves with professionally recorded music on a CD (two copies are required).  
In the case of a school wishing to present more than one choreography it will be necessary to produce two CDs for each choreography presented. The musical passages should then be identified by writing the style of dance, each passage, the duration of each piece, the choreography and the name of the school onto the CD label.

**Clause 9:** The stage carpet must be kept clean during the performance. It's forbidden the use of paint and talc powder on stage or spread on the body and the use of fire and candles.

**Clause 10:** The jury of the final competitions, indicated by the Organizer Team, will be composed of qualified experts chosen from teachers, choreographers, journalists and well-known TV personalities.

**Clause 11:** The judgement of the jury is irrevocable.

**Clause 12:** The Jury reserves the right not to award prizes in case of lack of deserving

competitors.

**Clause 13:** Choreography in wrong category could be moved or deleted from the Jury.

**Clause 14:** The lightning effects will be decided by the Director. Special needs of scenic elements should be communicated in a timely manner, but the organization does not guarantee the execution.

**Clause 15:** For each performance 5 minutes stage rehearsal will be granted. Each school or group may multiply the minutes according to the number of exhibition in the competition. Rehearsal must be booked by e-mail the day August 29, 2014. Without reservation schools will be queued to the lineup.

**Clause 16:** If for any reasons the Event should require changes, the changes will be communicated in accordance with municipal provisions and the Event could be moved into a location indoors.

**Clause 17:** Winners will be awarded to the Final Grand Gala Dance. Participants are not entitled to any compensation.  
Contest participants authorize the Organizer Team to purchase and use (unless you expressed a refusal in writing) video recordings as well as personal details for promotional, informative and statistical means in accordance with law nr. 675 of 21/12/1996.

**Clause 18:** Travelling and hotel expenses of the participants are totally at one's own expense.

**Clause 19:** All decisions will be made by the organizing committee as stipulated in the

regulations.

**Clause 20:** The organizing committee declines all responsibility for damage caused to persons or personal effects should it occur during the course of the various phases of the manifestations. Participants must be aware that one takes part at one's own risk.

**Clause 21:** Disclaimer of the children (minors) that must be accompanied and supervised by their teachers during all the time of the competition.

**Clause 22:** The Argentario Dance Festival introduces the possibility to all the fun of Hip pop category to participate to the "BEAT FIGHT CONTEST" dated Sunday, September 8, 2014 by selecting from the Argentario Dance Festival competition, section Hip pop, groups over 14. Will be selected the top 3 winners of the outgoing section, and 3 more groups, chosen by the jury, for the participation of BEAT FIGHT CONTEST having the opportunity to win the 1000 and put up for grabs. The rules of participation in the contest are very simple:  
the number of crew must start from a minimum of 3 dancers to a maximum of 25 (no exceptions) styles of the choreography can be different and various, that is, to give free space to all styles of the Hip hop scene. Time for each choreography is 4 minutes. For any other information is valid the Regulation of Argentario Dance Festival that you can download at our website.
